

3D CHAMPS Accident Waiver and Release of Liability Form

I hereby assume all the risks of participating in this program, including by way of example and not limitation, any risks that may arise from negligence or carelessness on the part of the persons or entities being released from dangerous or defective equipment or property owned, maintained, or controlled by them, or because of their possible liability without fault.

I certify that I am physically fit and have not been advised to not participate by a qualified medical professional. I certify that there are no health-related reasons or problems which preclude my participation in this program. I acknowledge that this Accident Waiver and Release of Liability Form will be used by the organizers of the program in which I may participate and that it will govern my actions and responsibilities at said program.

In consideration of my registration and permitting me to participate in this program, I hereby act for myself, my executors, administrators, heirs, next of kin, successors, and assigns as follows:

(A) I WAIVE, RELEASE, AND DISCHARGE from all liability, including but not limited to liability arising from the negligence or fault of the entities or persons released, for my death, disability, personal injury, property damage, property theft, or actions of any kind which may hereafter occur to me, including my traveling to and from this program. I acknowledge that this program may carry with it the potential for death, serious injury, and personal loss. The risks may include, but are not limited to, those caused by terrain, facilities, temperature, weather, condition of participants, equipment, vehicular traffic, actions of other people including, but not limited to, participants, volunteers, spectators, coaches, and lack of hydration.

I give 3D CHAMPS, and/or their coaches, representatives, or volunteers, along with DRF and their affiliates, permission to use photographs, videos, audio clippings, digital recordings, and/or images of the below-named participant's participation in program activities for any promotional, media or marketing purposes. I further consent that my identity may be revealed therein or by description text or commentary. I waive any rights, claims or interest and I understand that there will be no financial or other remuneration.

The accident waiver, release of liability and image release shall be constructed broadly to provide a release and waiver to the maximum extent permissible under applicable law.
